# COWS CREATE CAREERS PROJECT

# TERMS AND CONDITIONS OF ENTRY

1. The Cows Create Careers Project ('the Project') is a skills based project that commences on **15th April 2024**.
2. All participating secondary schools ("Eligible Participants") must have received an e-mail from the organiser of the Project, Jaydee Events Pty Ltd of PO Box 18, LOCH VIC 3945 (ABN 19 113 519 789) (hereafter, "the Project Manager") confirming their eligibility to participate in the Project before the Project may commence at their school.
3. All material and resources required, including commercial feeding supplies and curriculum resources, will be provided to Eligible Participants as part of the Project.
4. Eligible Participants must meet or communicate with representatives of the Project Manager prior to the Project implementation to discuss timelines and to determine suitable facilities for the housing of the calves. Eligible Participants are responsible to adhere to National & State animal ethics and biosecurity regulations.
5. At the conclusion of this appointment, Eligible Participants must follow the instructions included in the 'Cows Create Careers School Resource Kit' provided by the Project Manager, in relation to the housing and management of the calves.
6. Eligible Participants must display the two A3 posters that have been provided and discuss the importance of Animal Husbandry and Personal Hygiene requirements with all students involved in the Project.
7. All curriculum work must be returned to the Project Manager for assessment by the **13th June 2024**.
8. All entries will be judged by an independent assessor and a prize of AUD\$250 will be awarded to the winning school of the region for the junior and senior sections. The student team from the winning school will receive a prize to the maximum value of AUD \$100 in vouchers (or a AUD\$20 voucher per student).
9. Winning schools will be eligible to submit a further entry to determine an overall National winning school for the junior and senior sections. The overall National winning school in the junior and senior sections will each receive AUD \$2,000
10. Eligible Participants must submit one entry comprising of one teams completed assessment task as outlined in the 'Cows Create Careers School Resource Kit' for a team to be eligible for the school prize. The winning school prize will be determined by the highest score from each of the teams that have been submitted from that region/State. Prizes will be awarded in both Senior and Junior sections if there are two or more schools in each section meeting the criteria.
10. The final winning entries will be announced by the **26th June 2024** at the Presentation and awards day.
11. The judge's decision is final and no correspondence will be entered into. The prize is not transferable or exchangeable and cannot be taken as cash.
12. By choosing to participate in the Project, Eligible Participants acknowledge and agree that, save only where liability cannot be excluded by law, the Project Manager shall not be liable for any loss or damage whatsoever which is suffered or incurred (including but not limited to indirect or consequential loss), or for personal injury which is suffered or sustained, as a result of the Eligible Participant participating in the Project.
13. Each Eligible Participant further acknowledges that the Project Manager shall collect information about the Eligible Participant and personal information on participating students and teachers in order to conduct the Project and agrees this information may be used in any media format for future promotional, marketing and publicity purposes without any reference, payment or other compensation being made or paid. Without limiting the generality of the foregoing, by agreeing to participate, the Eligible Participant warrants that they have obtained all necessary consents in writing for the use by Jaydee Events Pty Ltd and its affiliates of any and all photographs and/or other digital imagery submitted as part of the Project from all persons (or their guardians, as appropriate) appearing in such photographs and/or digital imagery. Jaydee Events Pty Ltd shall be at liberty to use and to publish any and all photographs and/or digital imagery submitted as it may choose in its absolute discretion and the Eligible Participant acknowledges and agrees that it shall submit only those photographs and/or digital imagery where consents from all persons appearing in the same have been formally granted in writing for the purposes aforementioned.
